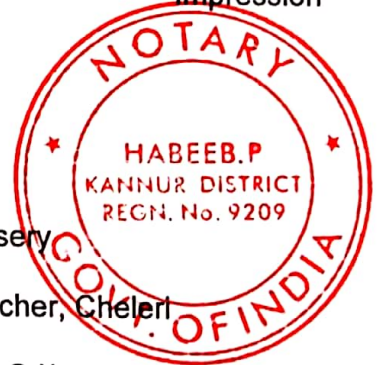

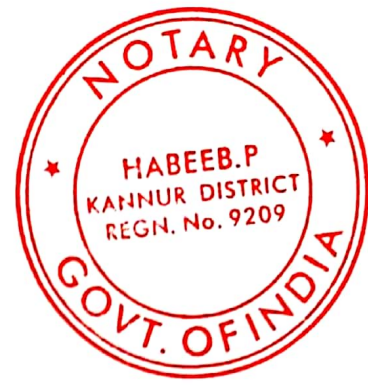

### IV Objectives

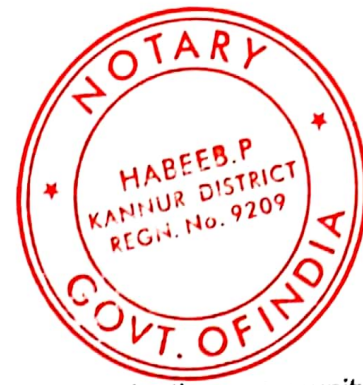
a) Establish and run nursery, primary, high school, higher secondary level educational institutions, colleges, vocational schools, engineering colleges, nursing schools and computer training institutes.

- d) To take initiative and work for the protection of the poor, the needy and the destitute in the society irrespective of caste or creed.
- e) To promote literature, arts, science, language, etc. and to award scholarships and financial assistance for the same.
- f) To build and run orphanages, health care centers, hospitals, orphanages and old age homes. Accumulate assets & funds to meet the above objectives, and to accept other charities and fee contributions.
- h) To conduct religious studies for Muslims as per the syllabus of the Samastha Kerala Sunni Educational Board.

#### **V The nature of the trust**

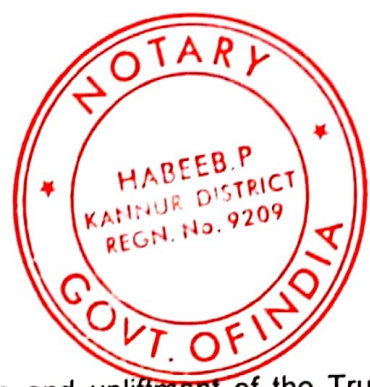
1. This trust is a charitable trust.
2. The beneficiaries of this trust will be all sections of the people.
3. The trust shall have not less than 5 and not more than 20 trustees.
4. The trustees should be the believers of the Ahlus Sunnah Wal Jama'ah, which is officially one of the Shafi'i, Hanafi, Hambali, Maliki and Madhhabs, or one of the truly recognized Ash'ari, Mathuridi, and Twareeqat.
5. The trustee must be an Indian citizen of not less than 18 years of age who contributes Rs. 5,000 (Rupees Five Thousand Only).
6. The present Trustees of this Trust are those mentioned in Section II who may continue to be Trustees for the rest of their lives.
7. Trustees should select a managing trustee from among themselves.
8. A.P. Aboobacker Musliyar has been appointed as the Managing Trustee from the newly arrived trustees and he will remain in office for the rest of his life.

9. Individuals interested in working for the best interests and upliftment of the Trust shall be determined by the Working Committee of the Markazu Sakhafati Sunniyya, located in the Karanthur area of the Kozhikode District, subject to the above conditions. However, the total number of trustees should not exceed 20.

10. If anyone of the trustee is acting against the best interest and progress of the Trust, the trustee may be removed from the position of trustee or other appropriate course of action after giving show cause notice and within 30 days of receipt of the notice at the discretion of the majority of the trustees, he may be removed from the position of trustee.

11. If any trustee is convicted of a criminal offence or engages in other immoral acts, the trustee may be removed from the position of trustee.

12. The Trustee shall continue to function even if the number of Trustees falls below five by removal of the Trustee due to death or resignation of the Trustees and the actions and decisions of the existing Trustees shall be valid.

13. In case of vacancy due to death or resignation of any of the Trustees of the Trust, a new person willing to act may be elected as Trustee subject to the above conditions at the discretion of the Board of Trustees.

#### VI. Powers and duties of trustees

a) The general management and management of the Trust are the collective responsibility and responsibility of the Trustees. The trustees carry out their functions collectively as a board of trustees.

**Board of Trustees:** Kanthapuram AP Aboobacker Musliyar, Managing Trustee and Dr. Mohammad Abdul Hakeem Azhari, C. Mohammad Faizi, K.K. Ahmed Kutty Musliyar, Dr. Hussain Saqafi Chullikode, Prof. A.K. Abdul Hameed and Marzooq Saadi P.T.P @ Muhammad Marzooq will also be directors. The Board of Trustees should be renewed every three years.

b) The trustees should meet at least three times in a year and give guidance to the managing trustee on the functioning of the trust. More meetings can be convened if needed.

c) Trustees may work for the betterment and advancement of the Trust. Trustees are required to submit the exact amount received and expended for the Trust to the Managing Trustee in a timely manner.

d) Trustees may accept and earn money and assets for the Trust. Use the money for the best interests of the trust. Collect assets and cash due to the trust. The Managing Trustee or other staff may be appointed for this purpose.

e) The activities of the trust are to be carried out by a majority decision of the trustees. The quorum of the Board of Trustees meeting shall be 2/3 of the total number of Trustees. If the quorum for any meeting is not met then the next meeting should be held on the same day and time next week and the quorum should be deemed to be complete regardless of the number of members present.

f) Trustees have the right to elect a managing trustee.

g) The trust has the power to borrow money as per the majority decision of the trustees when it comes to acquiring assets and day-to-day operations of the trust. The Board of Trustees may, at its discretion, obtain a loan from a bank or other financial institution and, in return, mortgage the Trust's movable and immovable property, if necessary. The Managing Trustee must sign all applications, records, bonds and all other required documents required for mortgaging and borrowing on behalf of the Trust.

h) The Trustees may approve their decisions in writing and distribute them among the Trustees and such decisions shall be deemed to have been taken at the meeting of the Trustees.

i) Sub-committees can be constituted with the approval of the Board of trustees to lead the periodic activities of the trust.

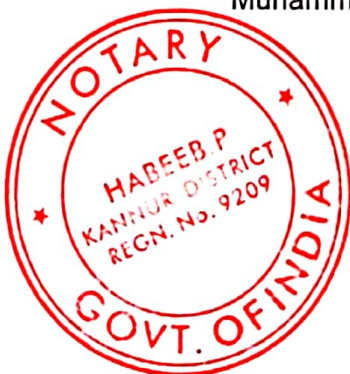
#### **VII Powers and Duties of the Board of Trustees**

a) The Board of Trustees shall be chaired by the Managing Trustee.

b) Appoint all types of officers required for the functioning of the Trust, lead the day-to-day operations and take disciplinary action, including dismissal of the officers.

c) The Managing Trustee must sign all documents, including petitions, contracts and applications on behalf of the Trust and to appear all Government, quasi-government, private institutions, boards, panchayaths, municipalities and various government departments on behalf of the trust.

d) The assets and property of the trust are to be purchased in the name of the managing Trustee on behalf of the Trust.

#### VIII) Trust Fund

A trust fund is a sum of money assets and assets received by donations from other individuals, institutions, or the government or provided by the founder of the trust and contributed by other trustees. In addition, the Trust Fund is the source of income and other income generated by the Trust Fund.

#### IX) Account/accounts

a) It is the responsibility of the managing trustee to keep a record of the trust's accounts accurately and honestly.

b) Accounts should be opened in the name of the Managing Trustee on behalf of the Trust in the Banks determined by the Trustees.

c) The Managing Trustee should keep a record of the Trust's accounts for the financial year and at the end of the year audit the accounts with the Chartered Accountant and prepare a statement of assets and liabilities of the Trust's income and expenditure and submit it to the Board of Trustees. An annual budget for the activities of the trust should be prepared and submitted to the trustees' meeting for discussion and approval.

d) A budget should be prepared in every year for smooth management of the trust and submitted to the trustees' meeting for discussion and approval.

e) The necessary amendments may also make in The Trust Deed to operate the same under the Trust Income Tax Rules.

X) Cancellation of the Trust: In case of inability to continue the operation of the Trust for any reason, the assets and liabilities will be transferred in the name of Markazu Zakhafathu Sunniyy located in Kundamangalam in Karanthur Village in the Kozhikode District or otherwise reserved by the Government.

As the founder of the trust, I have decided and consented to sign the Trust Deed and register it with the Sub Registrar Office, Kallyassery on behalf of the Trust on the basis of this trust which is not subject to any determination.
